Dubai Company Formation

Limited Liability Company (LLC) is the most common form business in UAE. A Limited Liability Company can be formed by a minimum of 2 and a maximum of 50 shareholders whose liability is limited to their shares in the businesses capital.

Most companies with foreign partners have opted for the Limited Liability Company, due to the fact that this is the only option that'll give maximum legal ownership i.e. 49% to the expatriates for a local business. As it is mandatory to have a UAE national as a partner in the LLC (51% shareholding) prospective investor has the option to choose the one UAE national (sponsor) as a partner in the company.

Free Zone Company Setup

Free Zone Company Setup in Dubai, is the best way to start up 100% owned company by yourself. there are no need of a local sponsor, these company are hold and controlled by a free zone authority, so it will be always easy to any documentation and other process. like visa process, cancellation etc.

- Free zone company formation is quicker than incorporation outside of the free zones UAE

Offshore (IBC – International Business Company) Company Formation:

- No residence visa for founders and directors. Shareholders and/or directors of an Ajman Offshore are not automatically eligible to obtain a UAE residence visa from the offshore company opened.
